# CLINTON COMMUNITY SCHOOL DISTRICT REGULAR SCHOOL BOARD MEETING February 6, 2017

President Ken Luety called the meeting to order at 6:30 p.m. The Pledge of Allegiance was recited. School board members present were: Gary Gilbank, Jill Gunderson, Ken Luety, Melissa Manthei and Evelyn Propp. Absent: Tom Howard. Administration Present: Jim Brewer, Dan McCrea, Nichole Erickson, Matthew Huettl, Sally Barrington, Julie Cornelius, Janae Gile, Jeff Spiwak, Ben Simmons, and Heidi Simms. Jill Gunderson made a motion to approve the agenda as presented, seconded by Melissa Manthei. Motion carried by a voice vote. (Yes: 5, No: 0).

Citizens and Delegations: None.

Clinton Elementary School Teacher, Emily Fleming, was recognized as the February 2017 Staff Member of the Month.

Jill Gunderson made a motion to approve the consent agenda as presented. Consent agenda items are: A) Approval of previous meeting minutes from the regular school board meeting minutes from January 9, 2017, and B) Approval of receipts and expenditures from January 16, 2017 and January 31, 2017. Evelyn Propp seconded the motion and the motion carried with a roll call vote. (Yes: 5, No: 0).

Gary Gilbank made a motion to approve the personnel report as presented. Motion seconded by Melissa Manthei. Motion carried with a roll call vote. (Yes: 5, No: 0).

#### Academics:

CHS Band Teacher, Ben Brueggen, reviewed information regarding the Tri-State Honors Band Trip to UW-Platteville February 10<sup>th</sup> & 11<sup>th</sup>. Board discussion. Jill Gunderson made a motion to approve the overnight trip as presented. Gary Gilbank seconded the motion. Motion carried with a voice vote. (Yes: 5, No: 0)

Mr. Brueggen reviewed the preliminary itinerary for the 2018 band trip to Florida. The trip is an 8 day, 7 night motor coach tour to Orlando. General board discussion. Jill Gunderson made a motion to approve the trip as presented. Board discussion. Gary Gilbank seconded the motion. Motion carried with a voice vote. (Yes: 5, No: 0)

Mr. Brewer proposed a change in teacher start times and school start times for the 2017-18 school year. Melissa Manthei seconded the motion. Motion carried with a voice vote. (Yes: 5, No: 0)

Melissa Manthei and Mr. Brewer reviewed the policies up for first reading: 7230 – Gifts, Grants and Bequests and the creation of a new policy 7250.01 – Memorials and Dedications. General board discussion. No action.
