



# Summer Credit Recovery & Course Completion FAQ

High School Summer school credit recovery will be offered in partnership with Rural Virtual Academy on the OdysseyWare online platform. **Students must attend in person at CJSHS.**

Course Completion for Middle School Students will be offered during summer school at pre-scheduled times with teachers to complete a course that they earned a 0 or a 1 (No Evidence or Beginning). **Students must attend in person at CJSHS.**

## What is Credit Recovery

Credit recovery is a strategy that encourages at-risk students to re-take a previously failed course that is required for high school graduation. By completing the course requirements for a previously failed course, the student will earn credit for that course. All credit recovery courses are graded as a pass or fail. Credit will be earned with a passing score.

Credit Recovery courses have minimal pacing guidelines to complete the course content by the scheduled end date. Students may work at a faster pace and/or put in additional time outside of the scheduled summer school dates/hours to complete the course sooner.

Session 2: Monday, July 8- Friday, July 26, 2024

## **How do I know what Credit Recovery Courses I need to enroll in?**

**For High School:** Only required Math, Science, English or Social Studies classes that were failed and cannot be made up in future years may be taken. You will receive a letter or communication from the school if you are eligible to recover a course in summer school.

**For Middle School,** core classes in which a student has earned a 0 or a 1 as an overall grade will need to participate in course completion.

Teachers will determine which topics need to be covered and tailor credit recovery directly to student needs. In a case where a student has multiple courses to complete, administration will prioritize those courses.

## **When is the Deadline to Enroll in Summer Credit Recovery Courses?**

Preferred enrollment deadline Monday, June 10, 2024. Please note that there is a cap for the number of students enrolled in these courses and there may be a waiting list, so registering early is recommended.

It takes about four business days to enroll a student, so be sure to register early. Early registration will ensure the student is in the system before the start date of Summer School (Wednesday, June 12, 2024).

## **What are the Requirements once a Student is enrolled?**

Students are required to keep up with the daily schedule. If **after four days** the student is not on pace, he/she will be dropped from the course.

Process/procedure for ENGAGEMENT/COMPLETION

2 days of not being on pace-- student contacted

3rd day of not being on pace--parent contacted
